- Candidates are responsible for familiarizing themselves with the Waterloo Undergraduate Student Association's by-laws, elections & referenda procedures, and all other applicable organizational documents.
- Candidates are encouraged to submit their information mainly through the online nomination process on vote.wusa.ca for inclusion in WUSA Elections promotional materials. If you choose to forgo the online process, please provide the following information in addition to this form: name, team name (if applicable), program and year, previous applicable involvement with WUSA/Waterloo (point-form), top three platform points (option to expand in section below or direct to external link/contact for full platform, but this area is to be brief point-form and not the place to expand on these points), a maximum 100 word bio/reasons why someone should vote for you, and any links to website/social/email address.*

Duties as Vice President



The Vice President works with students, staff, and organizations (both internal and external to the University) to work towards high-quality and affordable post-secondary education.



The Vice President often provides for the representation of the Corporation when more than one representative is required at official university functions and on public occasions, or when the President is unable to attend.



The Vice President is responsible for advocating on behalf of University of Waterloo undergraduate students to the Government of Ontario, and the Government of Canada, on all matters related to postsecondary education.



The Vice President is the lead of the directors who also sit on external Government-facing bodies such as the Ontario Undergraduate Student Alliance (OUSA) and Undergraduates of Canadian Research-Intensive Universities (UCRU), and other committees to advocate for student issues.



The Vice President works with the WUSA Research team to conduct examinations into post-secondary education and uses data to develop policy and stances for the Corporation, sometimes in collaboration with larger advocacy bodies.



The Vice President works with the Advocacy team to develop and maintains relationships with government and external stakeholders.



The Vice President is eligible for officer roles in larger advocacy organizations, such as the Ontario Undergraduate Student Alliance and the Undergraduates of Canadian Research-Intensive Universities, as the normal University of Waterloo representative.



The Vice President maintains and promotes relations between the undergraduate students of the University of Waterloo, the Regional Municipality of Waterloo, and the local area municipalities in which there is a University campus. The Vice President will normally represent the Waterloo Undergraduate Student Association to community organizations established to promote student welfare when it comes to issues such as transit, safety, and housing.



The Vice President will ensure that the Waterloo Undergraduate Student Association maintains links with community groups that can assist in student success. Additionally, the Vice President will be a representative to these groups.



The Vice President is expected to fulfill additional duties as required of their role, including involvement with teaching awards, curricular changes, various academic committee work, and various other duties in line with the spirit of advocating for students in government relations, academic, and cooperative education areas.

Time Commitment:



The term of office for the Vice President is from May 1, 2023, to April 30, 2024, and is a full-time position. The Vice President will also be expected to attend certain events outlined in their role description that may fall outside of regular working hours, including committee meetings, serving official functions, and certain public occasions.

Candidate Eligibility:

Candidates for the Vice President position must be full members of the Waterloo Undergraduate Student Association. According to the bylaws, a full membership is defined as follows:

- 1. Each undergraduate student currently registered at the University of Waterloo.
- 2. Each undergraduate student currently registered in a co-operative work term at the University of Waterloo.
- 3. Each person who was an undergraduate student in the previous term who has not withdrawn or graduated from the University.
- 4. Each Officer of the Corporation who (i) was elected as an Officer while an undergraduate student, (ii) has graduated from an undergraduate program at the University, and (iii) has yet to complete his/her/their term of office.

The Vice President is a Director on the Board, which has the following additional requirements:

- 1. Must be at least 18 years of age;
- 2. Must not be a person who has been found under the Substitute Decisions Act, 1992 or under the Mental Health Act to be incapable of managing property;
- 3. Must not have been declared incapable under the laws of a Canadian province or territory, or by a court in a jurisdiction outside Canada;
- 4. Must not be an employee of the Corporation; and
- 5. Must not be an undischarged bankrupt or expect to become bankrupt during the duration of the term of office.



Nominations for Executive Officer positions require the signature of the candidate and the signature of one hundred (100) other electors.



The Chief Returning Officer, or designate thereof, with the assistance of the Executive Director, shall verify the validity of each nomination form. If a nomination is invalid, the nomination will be rejected, and the candidate will be notified. Candidates whose nominations are rejected after the end of the nomination period will have two business days to make corrections and amendments.



Candidates who have not clarified their membership status by either adding sufficient classes to their schedule or arranging their fees will not be allowed to stand in the election.

How much does it cost to run?

Officer campaigns have a strict spending budget of \$375.00 per candidate. Campaign teams may receive a higher spending limit depending on the campaign team size. Candidates will receive a reimbursement from the Waterloo Undergraduate Student Association for up to one hundred per cent of their spending budget. Spending budgets for campaigns can be found in the WUSA Elections and Referenda document [Section 7.1]. Candidates, campaign teams, and referendum committee accruing three (3) or more demerit points will receive a reduced reimbursement. Disqualified candidates are not eligible for this subsidy.
