How to Enter (No purchase required)

Participants must visit any WUSA event during the contest period and check in by using their student ID (WatIAM) credentials.

Eligibility

The contest is open to all current registered undergraduate students at the University of Waterloo. Participants must be legal residents of Canada and of the age of majority in their province or territory of residence.

Prize

The grand prize offers the winner their choice of a Samsung Galaxy Watch 8 or an Apple Watch Series 11 — along with an exciting collection of WUSA prizes to elevate your campus experience! (Approximate retail value (ARV) of the Samsung Galaxy Watch 8: approx. \$629 CAD; Apple Watch Series 11: approx. \$719 CAD. ARVs of secondary prizes are detailed below.)

The selected contestant must also correctly answer a mandatory timed mathematical skill-testing question consisting of at least three arithmetic operations (e.g., multiplication, division, and addition or subtraction), to be answered without assistance (no calculator or third-party aid permitted) to be declared the winner, subject to meeting all the conditions outlined in these rules.

Winner Notification

Winners will be contacted via their University of Waterloo email. They must respond within 48 hours to claim their prize. If a winner cannot be reached or fails to respond, an alternate winner will be selected.

Prize Claim

Prizes must be claimed in person within 14 days of notification. Winners must present a valid WatCard as photo identification. Prizes are non-transferable and cannot be exchanged for cash or substitutes.

Publicity Release

By accepting a prize, the winner agrees to WUSA's use of their name and general likeness (e.g., first name and university affiliation) for contest related announcements and promotional purposes, without additional compensation. Winners who do not wish to be identified publicly may contact WUSA prior to prize acceptance to discuss alternatives.

- WUSA reserves the right to disqualify any entry that violates these rules or is deemed inappropriate.
- WUSA is not responsible for technical or human error that may occur during the entry process or prize selection.
- WUSA may modify, suspend, or terminate the contest for any reason.
- All personal information will be collected solely for the purpose of administering the contest.

This contest is governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein.
